## 4. First-aid measures

### Inhalation

Move to fresh air. Call a physician if symptoms develop or persist.

### Skin contact

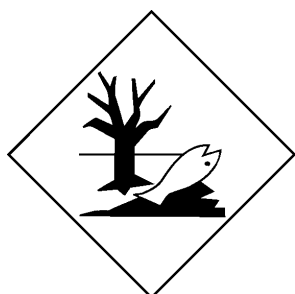
